

## **Minutes of a Meeting of Ciliau Aeron Community Council held on 4<sup>th</sup> July 2019 at 7.30 pm at the Cilcennin Village Hall**

### **238 Apology**

Councillor Helen Evans apologised for her inability to attend the meeting.

### **239 Minutes of the Last Meeting**

It was **RESOLVED** to approve as being correct the Minutes of the meeting held on 6<sup>th</sup> June 2019, subject to minuting

### **240 Matters Arising from the Minutes**

Minute 231 – the Clerk stated that the cheque for the Ceredigion National Eisteddfod 2020 had been refused by the Bank because there were insufficient funds in the current account. The Clerk apologised for this and it was agreed to transfer funds from the deposit account to the current account in order to ensure that there were sufficient funds to meet the Council's expenditure.

### **241 Finance Matters**

It was **RESOLVED:**

- a) to pay the invoice received from Alwyn Davies (cutting growth at the Cilcennin footpath) in the sum of £300
- b) to renew the Council's insurances with ZMI in the sum of £454.38.

### **242 Proposals for creating an Area School in the Aeron Valley**

Consideration was given to the Ceredigion County Council Consultation Document on the creation of an Area School in the Aeron Valley, which included seven options.

Following discussion, it was **RESOLVED** to support the first option, namely building a new area school on a central location in the Aeron Valley for Ciliau Parc, Dihewyd and Felinfach Schools.

**243 Planning Matters – Review of the Local Development Plan**

The Clerk stated that the County Council had published a document entitled Ceredigion Local Development Plan (LDP) 2018 – 2033: Consultation on the Preferred Strategy; and Consultation on Additional Candidate Sites.

It was **RESOLVED** to respond to the consultation and recommend that the land to the rear of Cilcennin Church be earmarked for amenity purposes.

**244 Road Accidents on the A482 Ciliau Aeron.**

Consideration was given to the request of one of the residents of Ciliau Aeron for the Council to support her latest request to introduce a speed limit on the length of the A482 to the west of the village.

It was **RESOLVED** to support the request and to contact the County Council in that regard.

**245 The Request of the Residents of Apple Tree Cottage to name the lane adjacent to their bungalow**

Consideration was given to the request of the residents of Apple Tree Cottage to name the lane adjacent to their bungalow.

Following discussion, it was **RESOLVED**, should the County Council approve the request, that the lane be named 'Heol Pentre Isaf'.

**246 Provisional programmes for highway maintenance work 2019-20**

It was **RESOLVED** to welcome the programmes and note that several schemes had already commenced.

**247 Ceredigion County Council Rights of Way Improvements Plan**

It was **RESOLVED** to note the contents of the Ceredigion County Council Rights of Way Improvements Plan.

**248 Any Other Relevant Matter**

- a) Councillor Dai Evans stated that the rat problem had been dealt with.
- b) it was agreed to discuss the Chairman's Chain at the next meeting.
- c) County Councillor Marc Davies stated that he would follow up the matters raised previously by the Council, namely the placing of road signs and the condition of the Tyglyn Bridge and the New Bridge.
