## 249 Apologies and Personal

Councillors Arwel Jones and Ray Williams apologised for their inability to attend the meeting. It was noted that the medical treatment being received by Councillor Williams was continuing and best wishes were extended to him.

#### 250 Disclosure of Interest

Councillor Alwen Thomas disclosed a personal and prejudicial interest in the matter referred to in Minute 254b) below and took no part in the discussion or voting thereon.

# 251 Minutes of the Last Meeting

It was **RESOLVED** to approve the minutes of the meeting held on 5<sup>th</sup> July 2019, as being a correct record.

#### 252 Matters Arising from the Minutes

a) Minute 244 – it was noted that a further two accidents had occurred since the date of the last meeting and Members expressed their concern about the situation. County Councillor Marc Davies stated that the matter was under consideration by the County Council and that a review was planned for October.

It was **RESOLVED** to request the County Council to take immediate steps to deal with the obvious problem with this length of the A482, including asking the Council to consider providing an anti-slip surface on the road.

b) Minute 245 – notice had been received from the County Council that no request had been received to name this road.

- b) a request by Cylch Meithrin Felin-fach to defer the application and to request a copy of the most recent accounts for the Cylch before considering the matter further.

#### 255 Extending the Cycle Track from Llanerchaeron to Ciliau Aeron

It was noted that a feasibility study was being undertaken into the proposals for extending the cycle track from Llanerchaeron to Ciliau Aeron with the long-term aim of linking it to Lampeter and Tregaron.

#### 256 Up-dating the Chairman's Chain of Office

The information available in respect of Council Chairmen between 2013-14 and this year was noted. It was also noted that the Clerk did not have copies of the minutes between 1999 and 2015 and he was requested to contact the former Clerk in order to obtain these minutes and retain them in one place and obtain details of the former Chairmen at the same time.

#### 257 Planning Application A190568 - Henfaes, Cilcennin

Consideration was given to planning application A190568 - Henfaes, Cilcennin. Proposed demolition of single storey side lean-to and conservatory extension and proposed rebuilt single storey side kitchen and dining room.

**Decision:** No objection.

- a) the Clerk was requested to ask again for an up-date on the work of erecting new road signs and the survey of the condition of New Bridge (Tegfan).
- b) the Clerk was requested to draw the attention of the County Council to the fact that the street light near Bidarren was on all day.
- c) it was noted that the Council would be contacted shortly by the County Council with regard to the future of the building and the yard of Cilcennin Primary School; and it was agreed that there was a need to deal with the gate placed on the wall which adjoins the grounds of the Chapel.
- d) it was noted that the Cabinet of Ceredigion County Council at its meeting the day before yesterday had resolved to create a new area school on a central location in the Aeron Valley, namely the first option in the consultation

document, and that a Statutory Notice had been published to that effect, with any objections to reach the Council by 13<sup>th</sup> October 2019.
