259 Apologies

Councillors Robert Davies and Ray Williams, together with County Councillor Marc Davies, apologised for their inability to attend the meeting.

260 Disclosure of Interest

Councillor Alwen Thomas disclosed a personal and prejudicial interest in the matter referred to in minute 264 below and took no further part in the discussion or voting thereon.

261 Minutes of the Last Meeting

It was **RESOLVED** to confirm, as being correct, the minutes of the meeting held on 5th September 2019.

262 Matters Arising from the Minutes

a) Minute 252a) – Accidents on the A482 at Ciliau Aeron

It was **RESOLVED** to request the County Council to expedite dealing with the obvious problem on this length of the A482, and also requesting the Council to consider placing anti-skid surface on the road.

b) Minute 258 d) The decision of the Ceredigion County Council Cabinet to build a new area school at a central location in the Aeron Valley: The Clerk was requested to confirm with Members as to whether the Statutory Notice had been sent to the Council and whether there was any need to send any further comments on the matter.
