320 Apologies

321 Minutes of the Last Meeting

It was **RESOLVED** to approve, as being correct, the minutes of the meeting held on 5th March 2020.

322 Planning Application A190813 - Avicenna, Bidaren, Cilcennin. Erection of packing and distribution building.

It was noted that the planning application would be considered by the County Council Development Control Committee on Wednesday 8th July 2020, and that there was a right to send written representations for presenting to the meeting on the day.

The report of the Officers was noted and that the recommendation was to approve the application subject to conditions and that the Highways Authority had set twelve conditions.

It was **RESOLVED** to draw the attention of the Development Control Committee to the following:

- 1 The conclusion that the development meets the requirements of the Local Development Plan and National Policies is questioned as it is acknowledged by the Local Planning Authority that it is within a green field site and that the original advice was to ask the developer to erect the building closer to the existing buildings. The Council therefore remains of the opinion that the development is not in a suitable site in the context of planning rules.
- 2 The Council rejects the conclusion that the design of the proposed building is suitable and appropriate for a rural location.
- 3 The Council notes the twelve conditions set by Technical Services (Highways) which the planning permission are subject to their implementation. The Council would appreciate an explanation as to how the Planning Authority will monitor the development in order to ensure that the conditions are being met by the developer some of them to be completed before the building is allowed to be built and it is requesting for written confirmation from you when you are satisfied that the conditions have been met.

Planning Application A200432 Pentwyn, Cilcennin. Variation of condition 4 (occupied dwelling) of planning permission 901083.

Consideration was given to the above-mentioned application.
