

Minutes of a Meeting of Ciliau Aeron Community Council held on 5th November 2020 at 7.30pm by way of remote attendance

340 Apologies

Councillors Robert Davies, Dai Evans a John Lumley, and County Councillor Sir Marc Davies apologised for their inability to attend the meeting.

341 Procedure and Personal

In the absence of the Chairman, Councillor John Lumley, the meeting was chaired by the Vice-Chairman, Councillor Iwan Thomas.

Councillor Lumley was wished a speedy recovery.

342 Disclosure of Interest

Councillor Arwel Jones disclosed a personal and prejudicial interest in the planning application considered under Minute 350 below.

343 Minutes of the last meeting.

It was **RESOLVED** to approve, as a true record, the minutes of the meeting held on 1st October 2020.

344 Matters arising from the Minutes

The matters listed in the following three minutes were considered and agreed.

345 Public Footpaths Within the Community

It was **NOTED** that the Clerk had not received a response to date to his enquiry about the County Council's policy for keeping open public footpaths in communities.

346 Pavement and Road fronting Cae Morgan, Cilcennin

The Clerk stated that he had received the following information from the County Council on both matters:

- a) Excessive growth on the pavement: the estate road had not been adopted therefore the pavement was private land.

- b) Water escaping onto the road: an officer would shortly be coming out to inspect the matter.

The information provided by the Clerk was **NOTED**.

347 Competition – Dealing with Dog Mess in the Community

It was noted that the Clerk had been in contact with Ysgol Gynradd Ciliau Parc in order to arrange a competition to design a sign encouraging dog owners to pick up the mess left by their dogs when taking them for a walk and that the closing date given was the last day of November.

It was **RESOLVED** to agree that the Chairman and Vice-Chairman judge the competition and the prizes total £50.

348 Inconsiderate parking on the B4339

It was noted that the Clerk had been in touch with the Police and that they would be arranging investigating the matter, subject to other demands and available resources. No further information had been received to date. The Clerk had shared this information with the Clerk to the Llanfihangel Ystrad Community Council.

349 Finance Matters

It was **RESOLVED**:

- i) to pay Alwyn Davies for cutting growth on footpaths in the sum of £300 (Clerk's reimbursement); and
- ii) to agree to share the Zoom annual subscription with Llansantffraed Community Council and to contribute 50% of the net cost, namely £60.

350 Planning Applications

It was **RESOLVED** not note the comments sent in respect of the following planning applications following exchanging comments by way of emails.

b) The Clerk was requested to refer the following matters to the County Council:

 - the metal sign at the Crossway junction had rusted
- c) Councillor Gwyndaf Morgan agreed to raise at a local level the Council's wish to extend the cemetery at Cilcennin.
