It was noted that Ben Lake MP had offered to meet with Members in order to discuss the matter and it was agreed to request the Clerk to arrange the meeting and consider the matter further.

420 Any Other Competent Matter

- a) It was **RESOLVED** to request the County Council to provide a bus stop both sides of the road at Sqwar y Graig
- b) It was noted that the two litter picking sessions had been a success and all those who took part were thanked.
- d) Cilcennin School Building. Consideration was given to the information received from the County Council stating that the panel would be considering at its next meeting any feedback received to the consultation, and also to consider other available options for the site (for example, as part of the local economic strategy, the panel was keen to consider the idea of creating a work / living unit which could hopefully be of interest to a local person or family). Another option under consideration was selling it as it stands on the open market.

It was **RESOLVED**

- i) to support the idea of developing it as a work / living unit for a local family; and
- ii) to express concern about the future of the field which forms part of the property, should it not be offered as part of the development package, and that the Council would like it being kept for leisure and amenity purposes and that it would be happy to discuss this further with the County Council.
- d) The Clerk was asked to request the County Council for an update on the proposal to sell the piece of land for affordable housing at Parc yr Hŷdd, Ciliau Aeron.
- e) It was **RESOLVED** to aim to hold the September meeting in one of the Halls.
