427 Cilcennin Church Cemetery

428 Wefibre Broadband Scheme

The discussion with Ben Lake MP in respect of the recent Open Reach announcement for extending their broadband service to rural areas in Ceredigion, which could have an effect the Wefibre scheme, was reported.

It was noted that the DCMS had not responded to Ben Lake's enquiries on the matter and there was confusion in respect of the Felinfach exchange at the present time.
