Minutes of a Meeting of Ciliau Aeron Community Council held on Thursday 2nd December 2021 at 7.30 pm at the Ciliau Aeron Village Hall

463 Apologies

Councillors Nigel Davies, Arwel Jones and Gwyndaf Morgan apologised for their inability to attend the meeting.

464 Dyfed Powys Police

It was noted that PCSO Charlotte Carter had attended an open session held before the meeting when several matters were discussed.

When introducing PCSO Carter, County Councillor Marc Davies had referred to the intention of the County Council, in accordance with any direction received from Welsh Government, to introduce an Order which would reduce the 30 mph speed limit on County roads in every area to 20 mph. In welcoming this, it was apparent that its implementation would cause problems to the Police due to a lack of resources.

It was not anticipated that Welsh Government would be introducing a scheme to reduce 40 mph speed limits to 30 mph at this time. Despite that, there would be an opportunity to submit comments prior to any proposals being introduced in the County.

PCSO Carter outlined her role within the community, which included working with schools and with regard to the problem of speeding in several areas working with the Traffic Unit and the GoSafe Team in particular. She referred in particular to the following matters:

- Speeding in Cilcennin. PCSO Carter had already conducted an exercise and drivers had been warned about speeding. Further exercises of this kind would be undertaken.
- It was also agreed to contact the County Council requesting that signs be erected warning drivers to take care as the roads were used by cyclists and horseriders.
- PCSO Carter agreed to investigate the vehicles left on the side of the road near the Chapel on the road to Dihewyd.
- Dog mess. PCSO Carter stated that consideration was being given to making a request to the County Council for legal authority to be given to the Police to deal with people who did not pick up dog mess.

PCSO Carter was thanked for her presentation.

465 Minutes of the Last Meeting

It was **RESOLVED** to approve, as being correct, the minutes of the meeting held on 4th November 2021.

466 Matters Arising from the Minutes

Minute 454:

- a) Nothing further had been heard from the County Council after drawing their attention to the problem of water running down the private road from a culvert on the Newbridge hill at Ciliau Aeron
- b) The Clerk was requested to follow up with the County Council the Council's request for a 'flag and pole' bus stop at Sqwâr y Graig
- c) To note that the County Council had cut the growth on the side of the primary School on the A482 on Ciliau Aeron square but that the growth in front of the house on the other side of the junction had not been cut. County Councillor Marc Davies stated that he would follow this up
- d) Minute 459 The Joint Consultative Meeting with Ceredigion County Council. The Clerk stated that the answer received to the Council's request for the County Council to grit the road was that it was not possible to change the matrix which was the basis for the priority given to specific roads.
- e) Minute 462 it was noted that the County Council had not repaired the damaged 40 mph sign situated on the A482 to the north of Ciliau Aeron.
