46 Apologies

Councillor Arwel Jones apologised for his inability to attend the meeting.

47 Dyfed-Powys Police

PCSO Charlotte Carter was welcomed to the meeting and proceeded to share the following information with Members.

- Three calls had been received concerning vans which appeared suspicious but which had not resulted in any offences.
- Four scam telephone calls had been reported
- There had been an increase in cases of theft. The theft of stones from the Henfynyw Churchyard and Llanerchaeron was especially a matter of concern.

She had recently visited Ysgol Ciliau Parc to discuss various matters with the children.

There followed a discussion on the need to keep a closer eye on speeding in 20mph areas, especially in the town of Aberaeron, and it was stated that the possibility of a 'Speed watch' exercise was being considered.

The result of the enquiries made in respect of an individual who had recently moved to live in the area who had been the cause of concern in the village.
