66 Minutes of the Last Meeting

It was **RESOLVED** to approve, as being correct, the minutes of the meeting held on 1st December 2022.

67 Matters Arising from the Minutes

- a) Minute 43 It was noted that Councillor Ray Williams had been in the Ceredigion Archives in respect of the history of the construction of Cilcennin School and that it appeared that Tŷ Mawr had sold the land for the construction of the school. It therefore appeared unlikely that any covenant had been placed on the land. Councillor Williams stated that he would continue with his research.
- b) Minute 64a) the County Council was requested to repair the length of road to the north of Cilcennin near Blaenyresgair

68 Finance Matters

It was noted that the Ceredigion County Council fee for administering the May 2022 Election in the sum of £170 would be deducted from the first 2023-24 Precept payment.

69 2023-24 Budget and Precept

Consideration was given to the Draft Budget prepared by the Clerk for the 2023-24 financial year. Consideration was given in particular to the sum that should start to be put aside in respect of the financing of the Cilcennin Churchyard extension scheme. It was agreed to include £2,000 as a starting point for the project which would take place over several years, noting too that the Council would be making applications for financial assistance from other resources.

- iii) to set a Council Tax of £14 for Band D properties.

 - A tree across the waterfall path, Ciliau Aeron (45/337)
 - A need to attend to the footbridge near the waterfall path, Ciliau Aeron (45/336)
- b) Roads: To request the County Council to attend to the following:
 - 40mph sign on the A482 into Ciliau Aeron from the direction of Aberaeron
 - A vehicle having hit Newbridge.
- c) Councillor Ray Williams was thanked for organising a walk along several of the Cilcennin footpaths during the Christmas holiday period, noting that around 18 people had participated and that he was proposing a similar walk during easter time, along the Ciliau Aeron paths.
