Decision: No objection in principle but to express concern that charging a fee at the car park could lead to problems with vehicles being parked on the road leading to the Mansion.

## 89 Cilcennin Church Extension

## 90 Cilcennin School Building

The Clerk stated that he had not received any further information in respect of the County Council's intentions for the future use of the Cilcennin School building.
